SWIMMERS IN THE AGE GROUP EVENTS MUST COMPETE IN THEIR OWN AGE GROUP. ALL SWIMMERS ARE LIMITED TO COMPETING IN **FOUR (4) INDIVIDUAL EVENTS PLUS RELAYS PER DAY.** THE MILFORD AREA SWIM TEAM RESERVES THE RIGHT TO ENTER ALL TEAM MEMBERS IN THE MEET.

TIME

STANDARDS: NO TIME STANDARDS.

ELIGIBILITY: ALL SWIMMERS MUST BE REGISTERED WITH U.S.A. SWIMMING. REGISTRATION NUMBERS AND SWIMMER AGE MUST APPEAR ON THE ENTRY FORMS. **ALL SWIMMERS MUST BE PREPARED TO PROVE U.S.A. REGISTRATION.**

AWARDS: RIBBONS - 1ST THROUGH 12TH INDIVIDUALS - 1ST THROUGH 3RD RELAYS
INDIVIDUAL HIGH POINT PLAQUES FOR ALL AGE GROUP'S EXCEPT OPEN.

SCORING: INDIVIDUAL EVENTS: 16, 13, 12, 11, 10, 9, 7, 5, 4, 3, 2, 1
RELAYS: 32, 26, 24, 22, 20, 18, 14, 10, 8, 6, 4, 2

FINAL RESULTS: FREE TO EACH TEAM. IF YOU ENTER THE MEET BY HYTEX YOU'LL LEAVE THE MEET WITH YOUR RESULTS! ALL RESULTS WILL BE POSTED ON OUR WEB SITE.

SAFETY: OHIO SAFETY GUIDELINES WILL BE ENFORCED IN THE CONDUCT OF THE MEET AS WELL AS WARM-UPS.

COACHES: ALL COACHES MUST SIGN IN FOR EACH SESSION AND PRESENT A CURRENT U.S.A. MEMBERSHIP CARD UPON ENTERING THE POOL. THIS CARD MUST BE WORN WHILE THE COACHES ARE ON THE POOL DECK. OHIO SWIMMING REQUIRES THE MILFORD AREA SWIM TEAM TO ENFORCE THIS RULE.

DIRECTIONS: FROM I-275 TAKE EXIT 57 (BLANCHESTER/MILFORD) AND GO EAST ONTO RT. 28. TAKE THE NEW 28 BY-PASS AND TAKE THE FIRST EXIT (WOLFPEN/PLEASANT HILL ROAD – SOUTH) TURN RIGHT. GO TO SECOND STOP LIGHT AND TURN RIGHT ONTO EAGLES WAY. FOLLOW EAGLES WAY TO 3 WAY STOP SIGN AND TURN LEFT INTO MAIN PARKING LOT. ENTER THE POOL THROUGH THE JAMES H. FLEY ACTIVITY CENTER DOORS.
